## MEMBERSHIP LEVEL

An Executive Member entity maintains the right to be elected as an officer to the Board of Directors of the Alliance, and maintains the right to a voice and vote at membership meetings, may hold office, may sit on committees and/or Chair a committee, and have a voice and vote within that committee.

**GENERAL MEMBER - \$500.00:** Upon payment of the annual dues prescribed therefore, a qualified person or organization shall become a General Member if such entity meets the following:

- a. Works as a Representative of the Florida Media or Entertainment Industry or is a Florida resident or a Florida organization/entity that wishes to educate and support the business aspects of the industry; and
- b. Has obtained sufficient State and/or Federal Licensure to engage in said activity (if required by law) and is in good standing.

A General Member entity maintains the right to a voice at membership meetings, may sit on committees and/or Chair a committee, and have a voice and vote within that committee. General Member entities have no voting rights other than within committee.
